## Absolute Title's BJ Cirnigliaro Memorial Fund Makes \$25,000 in Contributions to Local Organizations

**Bedford, N.H. (Nov. 13, 2025)** – The BJ Cirnigliaro Memorial Fund, which was created in early 2021 by Absolute Title, has announced \$25,000 in donations to 11 local organizations, including the American Foundation for Suicide Prevention NH Chapter, Crispin's House Coalition for Youth, the Manchester Animal Shelter, Waypoint, Families in Transition, Easterseals New Hampshire – Veterans Count, My Breast Cancer Support, PFLAG New Hampshire and St. Vincent de Paul of Hampton, and first-time funding recipients, the National Alliance on Mental Illness (NAMI) NH Chapter and Friends of Aine.

Absolute Title, the region's leading title company with locations in Bedford, Concord, Portsmouth and Conway, New Hampshire, Lowell, Massachusetts, and South Portland, Maine, created the memorial fund to honor its longtime employee, BJ Cirnigliaro, who unexpectedly passed away in 2020. BJ was one of the company's first employees and, as senior vice president, opened the company's office in Portsmouth in May 2019.

"The organizations chosen this year continue to reflect the values and causes that meant so much to BJ," said Matthew Neuman, Esq., owner of Absolute Title. "Supporting their work allows us to honor her memory in a meaningful way, by spreading kindness and making a difference in our local community. BJ's spirit continues to inspire us and lives on through this fund and the good it supports each year."

The recipients of this year's donations were selected by a committee of Absolute Title employees and chaired by Lisa Capicchioni, senior loan officer at Guild Mortgage and longtime friend of BJ. This year's donations include:

• \$3,000 to the American Foundation for Suicide Prevention (AFSP) in support of the New Hampshire Chapter. The AFSP focuses on delivering innovative prevention programs, educating

- the public about risk factors and warning signs, raising funds for suicide research and programs, and reaching out to those who have lost someone to suicide.
- \$3,000 to Crispin's House Coalition for Youth to provide scholarship support to two Goffstown High School students pursuing higher education in the field of mental health.
- \$3,000 to Easterseals New Hampshire in support of its Veterans Count program. Veterans Count provides clinical and social services, as well as financial assistance, to service members, veterans and their families.
- \$3,000 to Friends of the Manchester Animal Shelter. The animal shelter takes in homeless, abused and abandoned animals and provides shelter, medical care and spay/neuter services to every animal that comes through its doors.
- \$3,000 to My Breast Cancer Support, a New Hampshire-based non-profit that provides assistance and support to those affected by breast cancer. The organization helps patients cover costs such as rent/mortgage payments, heat, car repairs, basic pantry supplies, utility/phone bills, car payments, etc., so that patients can worry less about money and focus on getting well.
- \$2,000 to Friends of Aine to support their mission of providing no-cost services to grieving children and families, helping them navigate to a hopeful path for the future.
- \$2,000 to NAMI in support of its NH Chapter. This grassroots organization provides support, education and advocacy for people affected by mental illness and suicide.
- \$1,500 to Families in Transition. Headquartered in Manchester, New Hampshire, FIT seeks to break the cycle of homelessness by providing housing programs, emergency homeless shelters, food programs and substance use treatment.
- \$1,500 to PFLAG in support of the New Hampshire chapter. PFLAG is the nation's largest organization dedicated to supporting, educating and advocating for LGBTQ+ people.
- \$1,500 to St. Vincent de Paul of Hampton to support its food pantry, community kitchen, clothes closet and durable medical goods programs.
- \$1,500 to Waypoint to support services for homeless youth.

The <u>BJ Cirnigliaro Memorial Fund</u> is administered by the New Hampshire Charitable Foundation and seeks to support suicide prevention programs, animal shelters and humane societies, and mental health and LGBTQ+ support organizations.
